MANURE MANAGEMENT PLAN

The manure management plan presented has been prepared to accompany the planning application of the farming business Braich yr Alarch Eggs for the erection of a 16,000 bird Poultry Unit.

The Water Code states that, to reduce leaching losses from manures, you should not apply more than 250kg per ha of total nitrogen in organic manures in any 12 months. However, these are guidline levels only and if a FACTS trained advisor can show that the crop requirements are higher the rates can be increased. The farm is not within a Nitrate Vulnerable Zone.

No manure will be spread upon the land at Braich yr Alarch. All manure is to be sold off farm (see Appendix 1).

The proposed development is an erection of a further 16,000 bird free range poultry unit at Braich yr Alarch. No stock is retained on farm.

Storage of Manure

All solid manure produced within the poultry unit will be removed every four days and sold directly off farm.

"Dirty" Yard Areas

The "dirty" yard areas on the farm will be kept to a minimum. This is due to the manure being contained in the poultry unit and removed every four days together with the hardcore area to the front of the poultry unit. Braich yr Alarch Eggs will require all areas to be clean outside the building as they will be producing food products within the unit.

The Braich yr Alarch proposal will incorporate the installation of a dirty water tank adjacent to the poultry unit. The waste water tank will be built in compliance with the SSAFO standards.

Contingency Plan

If manure should not be able to be exported, it can be stored in the manure store granted under planning permission 11/2019/0472/PF. Manure will be stored in accordance with SSAFO (Water Resources Act (Control of Pollution) (Silage Slurry and Agricultural Fuel Oil) (Wales) Regulations 2010).

All contaminated wash water will be stored in the dirty water tank upon farm.
